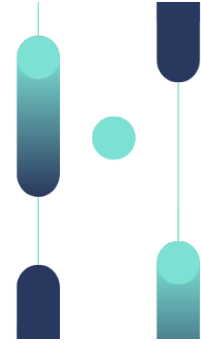


## SUSTAINABILITY POLICY

# EUROFORUM



At **Euroforum**, we are firmly committed to **sustainability** and **environmental responsibility**. We recognize the importance of minimizing our impact on the environment, promoting ethical practices and contributing to the well-being of the community.

Our commitment encompasses all our operations with the aim of preserving the environment and promoting a **socially responsible business model**.

**Blue Action** is the project created by Euroforum to encompass all the actions carried out within our **sustainability policy**. Its roadmap is based on moving towards decarbonization, efficient management and responsible and circular consumption.

**Blue Action** is based on **five lines of work**:

### 1. ENVIRONMENTAL MANAGEMENT

We strive to reduce our environmental footprint by implementing sustainable practices in all our processes. This includes:

**Energy efficiency:** we adapt technologies and practices that promote the efficient use of energy, the installation of LED lighting systems, motion sensors and efficient temperature controls. Our goal is the optimization of air conditioning and intelligent energy management in our spaces.

**Waste management and circular economy:** We implement measures to reduce, reuse and recycle waste generated during events. In addition, we promote awareness among attendees to avoid single-use products.

**Water conservation:** We adopt measures to reduce water consumption through the installation of efficient devices and the promotion of conscious practices.

**Technological innovation:** We continually explore new technologies and practices that allow us to improve our efficiency and reduce our environmental impact.

**Zero Paper:** We prioritize digital communication to minimize the use of paper and promote the use of recycled and recyclable paper.



## 2. ECO-AWARE EXPERIENCE

During our guests' stay at our facilities, we implement additional measures to ensure an overall environmentally-committed experience:

**Responsible consumption:** We encourage sustainable water and energy consumption practices in the rooms.

**Green cleaning products:** We use cleaning products that are biodegradable, non-toxic and sustainably manufactured. This reduces environmental impact and exposure to harmful chemicals.
